2. No. 1112 Delegate or Alternate Floor - 7th Session Only (orangish color)
3. Guest First Balcony 9th Session Only - Not Reserved (bluish color, torn off left corner)
4. Guest First Balcony 9th Session Only - Not Reserved (bluish color)

One might surmise that he attended the 6th Session because of the missing admission coupon and also the 9th session because of the torn off left corner

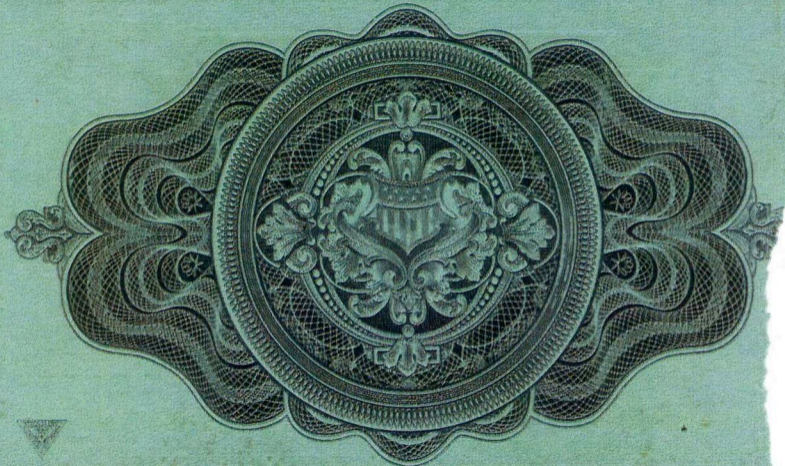

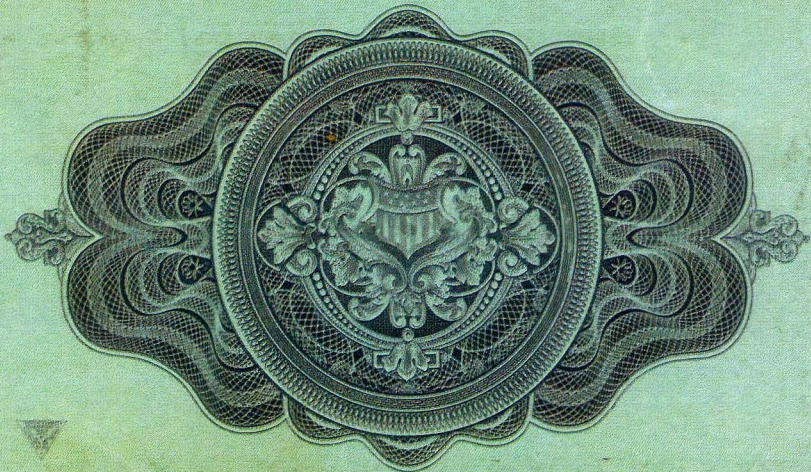
